The Application and Registration Fees are non-refundable and must be paid with the first fee invoice.

The Registration fee will be renamed "Capital Fee" with effect 1 January 2011 and be combined with the Application fee for a total of USD\$4500.00 from Kindergarten to Grade 8 and USD\$5500.00 for Grade 9-Grade 12..

Tuition Fees (all students)

All families are **required to complete and sign a Financial Undertaking Form including a Tuition Fee Payment Commitment indicating how they wish to pay tuition fees**. Failure to return/submit a signed Financial Undertaking will result in your child(ren) not being admitted. There are four options as set out below. Parents must read the Terms and Conditions set out overleaf before making the payment commitment.
